Sub: Establishment - Forest Department - Declaration of the posts of Forest Range Officers' as gazetted - Notification of the posts of Forest Range Officers in the Forest Department of the Government of Andhra Pradesh as specified gazetted category under six point formula - proposal - Submitted - Regarding.

Ref.: G.O. Ms. No. 188, Energy and Forest (For. IV) Department, dated 9.9.1993.

In the G.O. cited, orders were issued declaring the post of Forest Range Officer in the Forest Department as gazetted.

As per the scheme of localisation of cadres prepared by this Department and approved by the Government for implimenting the presidential order 1975, the category of Forest Range Officer is localised as Zonal category Zone - I to IV.

In the meeting held with Andhra Pradesh Junior Forest/Association and Andhra Pradesh Forest Range Officers Association on 15.1.1994, the Association have requested to continue the category of Forest Range Officers as Zonal category even after its declaration as gazetted.

The request of the Associations has been considered and it is decided to continue the existing unit of appointment of zone in respect of category Forest Range Officer. Hence, it is required to include as spcified gazetted category in the third scheduled of the Andhra Pradesh Public Employment (organisation of local cadres and regulation of Direct recruitment) order 1975 issued in G.O. Ms. No. 674, General Administration (S.P.P.A) Department, dated 20.10.1975 as required under rule 3(4) of those orders.

Accordingly draft amendment to Andhra Pradesh Public Employment Order 1975 is proposed for getting the category of Forest Range Officer to be included in IIIrd schedule of the said order for approval of the Government.

It is requested that the Government may be pleased to consider the above proposal and communicate the orders at an early date.
